## **PRO BONO** Program

As lawyers, we recognize that an important component of our practice is the responsibility to provide legal services to persons and entities of limited means. Following the firm's long-standing tradition of community service and social responsibility, the McConnell Valdés Pro Bono Program was established in 2006.

The program offers free transactional and legal advisory services to not-for-profit organizations serving persons of limited means or where the payment of legal fees would significantly deplete the organization's economic resources. The Pro Bono Program has partnered with the Puerto Rico Community Foundation and United Way of Puerto Rico to provide legal services and seminars to their member organizations and grantees.

During 2015, our attorneys used their diverse interests and skills to work on a variety of legal matters that ultimately benefited the communities in which we live and work. From drafting a certificate of incorporation and by-laws for a spin-off not-for-profit organization to obtaining federal tax exemption status for an alternative education program for at-risk students so that it can access additional funding for its program, our professional staff is deeply committed to serving the public good.




#### **Pro Bono Hours**
